## **FAQ**

- 1. Why did CF&G install a gate?
  - a. To satisfy Insurance requirements
  - b. To comply with Firearms Act requirements
  - c. To prevent further vandalism
  - d. To improve security for shooters at the range
- 2. What are FOBs?
  - a. A FOB is an electronic keyfob that is used to open the security gate.
- 3. Do I need a FOB?
  - a. The FOB unlatches the gate and signs the CF&G member in at the same time
  - b. Using FOBs will reduce the paper burden of manual sign in slips
- 4. How much do the FOBs cost?
  - a. 2015 Keyfob price \$15
  - b. Additional or replacement Keyfob price \$10
- 5. Where do I get a FOB?
  - a. You will be contacted by the membership committee once your 2015 application form has been processed
- 6. Why do I need to sign in at the range?
  - a. The CF&G requires all shooters to sign in upon arrival
  - b. The Firearms Act requires that restricted firearms users **must** sign in
  - c. Restricted PAL holders need to sign in to record their use of the range
  - d. The insurance liability policy requires CF&G to sign in all range users
- 7. Can a CF&G member use the range without a FOB?
  - a. Yes, the member may use the range without a FOB but must sign in manually.
- 8. Do I need a membership card if I have a FOB?
  - a. All CF&G members are required to carry and display their membership cards while at the range
- Can a CF&G member bring a guest?
  - a. Yes, providing the guest signs in using the members' number and pays a range fee of \$10
  - b. CF&G member is responsible for the guest following the posted range rules
  - c. The member must supervise any guest without a PAL (re: Firearms Act)
  - d. The CF&G member and guest must leave the range together
- 10. Who is the Range Officer?
  - a. The range officer is the first CF&G member at the range until a member with more experience takes over
- 11. Where do I get an application form?
  - a. CF&G website
  - b. Bucky's Sports
  - c. Canadian Tire, Sporting goods dept.
  - d. Gary Sutherland (Duncan Handgun Club)
  - e. CF&G range at the 100 yd range
- 12. I used to be a member, can I just renew?
  - a. Yes. if you held a membership the previous year
- 13. How do I become a NEW CF&G member?
  - a. Application form filled out correctly
  - b. Valid PAL if FOB is requested
  - c. Include two names and phone numbers of references, sign and date the form with a witness
  - d. Mail to the CF&G with the fee or put into the drop box at the 100 yd. range
- 14. How do I **renew** my membership?
  - a. Application form filled out correctly
  - b. References not required, sign and date the form with a witness
  - c. Mail to CF&G with the fee or put into the drop box at the 100 yd. range.
